7. Appointment of public officer

Alison Oakeshott retired from the position after 3 years. Marea England nominated to be public officer, which was accepted by the meeting.

## 8. Other business

Denis O'Brien gave a presentation about the North Canberra Community Council (NCCC) of which he is the chair. NCCC has provided some sponsorship of resident group activities within North Canberra eg Light Up Lyneham. It also gets involved in planning issues, for example NCCC joined in the ACAT appeal against the government's approval of the Coles development at Dickson shops. NCCC did not object to some development on the site but the proposal breached many of the planning rules. It was a long and complicated process but in the end

ACAT knocked back the development. Now waiting to hear what Coles will do.
Consultation process by EPSD Directorate over the site was poor but ACT government seem to be trying to improve their processes. The major consultation at present is on the City and Gateway Draft Urban Design Framework.

Alison Oakeshott noted that the recent storm flooding incident on Sullivans Creek affected many residents along Sullivans Creek. She asked the LCA to raise with Government what is happening about remediation and prevention of flooding in future.
